WHEREAS, Area 2 administers the public workforce development system in Summit and Medina Counties under an the SAMWA COG intergovernmental agreement dated November 1, 2016;

WHEREAS, WIOA programming supports local Adults, Dislocated Workers, Youth, and Employers by providing services designed to secure and advance employment opportunities, job retention, and the alignment of the workforce's skills with the local job market;

WHEREAS, SAMWA COG Resolution 2016-01, attached here as Exhibit A, adopted on the 30th of November 2016, approved a WIOA Program Year (PY) 2016 operating budget of \$3,218.388.00; and

WHEREAS, since the adoption of SAMWA COG Resolution 2016-01, Medina County has determined that additional WIOA Program Funds should be used to offer Individual Training Account (ITA) and On-the-Job Training (OJT) services in Medina County;

NOW, THEREFORE, BE IT RESOLVED,

SECTION 1

The SAMWA COG hereby adopts the revised Area 2 Operating Budget which includes a new Program commitment of \$100,000.00 of Medina County WIOA Adult and Dislocated Worker Program funds for the provision of ITA services in Medina County.

SECTION 2

The SAMWA COG hereby adopts the revised Area 2 Operating Budget which includes a new Program commitment of \$100,000.00 of Medina County WIOA Adult and Dislocated Worker Program funds for the provision of OJT services in Medina County.

SECTION 3

The SAMWA COG's hereby adopts a total revised Area 2 Operating Budget for Program Year 2016 in the amount of \$3,418,388.00 which reflects no changes to the Non-Formula Fund and WIOA Administration Operating Budgets.

SECTION 4

This Directive shall take effect immediately upon its adoption.

Authorizing, for the period of July 1, 2016 to June 30, 2017 ("WIOA Program Year 2016): 1) the proposed Ohio Local Workforce Area 2 ("Area 2") Workforce Innovation and Opportunity Act of 2014 ("WIOA") program operating budget for the purpose of providing workforce development services in Summit and Medina Counties, and; 2) the administrative operating budget for Area 2's Workforce Development Board ("WDB") to admin the local workforce system.

WHEREAS, Area 2 administers the public workforce development system in Summit and Medina Counties under an intergovernmental agreement dated November 1, 2016 between the chief elected officials which addresses the logistics of Area 2's functions and the process by which administrative tasks are carried out;

WHEREAS, this intergovernmental agreement established the Summit and Medina Workforce Area Council of Governments ("SAMWA COG") as the organizational vehicle through which the chief local elected officials exercise local oversight and ultimate authority over Area 2's workforce development activities, including budgeting;

WHEREAS, WIOA programming supports local Adults, Dislocated Workers, Youth, and Employers by providing services designed to secure and advance employment opportunities, job retention, and the alignment of the workforce's skills with the local job market; and

WHEREAS, in order to carry out the responsibilities of the WDB and to achieve the mandates of WIOA, it is necessary for the WDB to hire and/or appoint paid staff members who will administer and monitor public workforce development programing in Summit and Medina Counties;

NOW, THEREFORE, BE IT RESOLVED,

SECTION 1

The SAMWA COG hereby appropriates NON-FORMULA funds for the operating budget, in an amount not to exceed <u>\$217,650.00</u>, for the purpose of providing public workforce development program services in Summit and Medina Counties for WIOA Program Year 2016.

SECTION 2

The SAMWA COG hereby appropriates WIOA Adult, Dislocated, and CCMEP Youth FORMULA funds for the operating budget, in an amount not to exceed <u>\$3,218,388.00</u>, for the purpose of providing public workforce development program services in Summit and Medina Counties for WIOA Program Year 2016.
