

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS  
FOR OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2017-09**

**A Resolution of the Summit and Medina Workforce Area Council of Governments appointing Dr. Daryl Revoldt as the representative of an institution of Higher Education to the Summit/Medina Workforce Development Board.**

**WHEREAS**, the Workforce Innovation and Opportunity Act of 2014 (WIOA) Section 107 requires the membership of Local Workforce Development Boards to be representative of the Local Area's businesses, governmental, economic and community development entities, education and training institutions, and labor organizations;

**WHEREAS**, upon its formation, the Summit and Medina Workforce Area Council of Governments (SAMWA COG) assumed from the Medina County Board of Commissioners and the Summit County Council the responsibility of appointing and/or reappointing WDB members who represent the sectors required under WIOA Section 107;

**WHEREAS**, in light of Mr. Brian Malloy's separation from the University of Akron and in order to fulfill the compositional requirements of the WDB, the SAMWA COG must appoint a new representative of an institution of higher education to the WDB;

**WHEREAS**, in a letter addressed to County of Summit Executive, Ilene Shapiro, hereto attached as "EXHIBIT A," Dr. Para M. Jones, President, Stark State College, nominated Dr. Daryl Revoldt, Executive Director, Workforce and Economic Development, Stark State College, for appointment to the WDB as a representative of an institution of higher education, and;

**WHEREAS**, Executive Shapiro determined the nomination of Dr. Revoldt to be appropriate for the representative of an institution of higher education vacancy and through this motion recommends his appointment;

**NOW, THEREFORE, BE IT RESOLVED**, by the SAMWA COG that:

**SECTION 1**

Mr. Brian Malloy's term as the higher education representative to the WDB is hereby ended as of 3/6/2017;

**SECTION 2**

The appointment of Dr. Daryl Revoldt, to the WDB as a representative of an institution of higher education, with a term beginning 3/6/2017 and ending 6/30/2019, is hereby confirmed.

**SECTION 3**

This Directive shall take effect immediately upon its adoption.
