THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR OHIO LOCAL WORKFORCE AREA 2 RESOLUTION 2017-27

A Resolution of the Summit and Medina Workforce Area Council of Governments appointing Ms. Marquita Mitchell as the representative of a provider administering adult education and literacy activities under Title II of the Workforce Innovation and Opportunity Act of 2014.

WHEREAS, Workforce Innovation and Opportunity Act of 2014 (the "WIOA") Section 107 requires a local Workforce Development Board's ("WDB") membership to be representative of the workforce area's businesses, governmental, economic and community development entities, education and training institutions, and labor organizations;

WHEREAS, upon its formation, the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG") assumed from the Medina County Board of Commissioners and the Summit County Council the responsibility of appointing and/or reappointing WDB members who represent the sectors required under WIOA Section 107, as recommended by the Chief Elected Officials;

WHEREAS, pursuant to WIOA Section 107, the SAMWA COG must appoint to the WDB a representative of an eligible entity that receives funding to administer Title II adult educational and literacy activities, and in Area 2 the recipient of these funds is ProjectLearn of Summit County;

WHEREAS, due to the resignation of ProjectLearn of Summit County's Executive Director, Mr. Rick McIntosh, the SAMWA COG must now fill the WDB's vacancy for a representative of Title II adult education and literacy activities, as required by WIOA Section 107;

WHEREAS, in a letter addressed to Mr. Anthony Esposito, WDB Chair, hereto attached as "EXHIBIT A," Ms. Amanda Vowles, President of ProjectLearn of Summit County's Board of Directors, nominated Ms. Marquita Mitchell, Executive Director, ProjectLearn of Summit County, for appointment to the WDB as a representative of an eligible provider of Title II adult education and literacy activities in Area 2; and

WHEREAS, Medina County Commissioner Adam Friedrick determined Ms. Marquita Mitchell to be an appropriate representative of an eligible Title II adult education and literacy provider and recommends her appointment to the WDB;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

SECTION 1

The appointment of Ms. Marquita Mitchell to the Summit/Medina Workforce Development Board (the "WDB") as a representative of a provider that administers Title II adult education and literacy activities, with a term beginning 8/10/2017 and ending 12/31/2020, in alignment with Ohio Local Workforce Area 2's WDB Bylaws for Medina County appointments, is hereby confirmed.

SECTION 2

This Directive shall take effect immediately upon its adoption.
