A Resolution confirming the award by the Summit/Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for a subrecipient agreement with the United Labor Agency to provide Career Services in Medina and Summit Counties, in a not to exceed amount of \$1,468,155.00 during period of 10/1/2018 to 9/30/2019, with two 12-month renewal options.

WHEREAS, the State of Ohio's publically funded Adult and Dislocated Workforce Programs are served through Career Services provided under the Workforce Innovation & Opportunity Act (the "WIOA");

WHEREAS, the Ohio Department of Job & Family Services (the "ODJFS") allocates WIOA funds to Ohio's designated Local Workforce Areas;

WHEREAS, in Ohio Local Workforce Area 2 (the "Area 2"), comprised of Medina and Summit Counties, WIOA funds are received by the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG");

WHEREAS, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds;

WHEREAS, on 7/3/2018, Request for Proposal packet was released by the Summit/Medina Workforce Development Board (the "Area 2 WDB") for the provision of Career Services funded with WIOA allocations;

WHEREAS, based upon their evaluation of all submitted bids, the WDB's Performance Committee recommended at its 9/24/2018 meeting that the Area 2 WDB recommend the award of a contract by the SAMWA COG to the United Labor Agency (the "ULA") to provide WIOA-funded Career Services in Medina and Summit Counties;

WHEREAS, the Area 2 WDB recommended at its 9/26/2018 meeting that the SAMWA COG award the ULA with a contract to provide Career Services in Medina and Summit Counties;

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to confirm the WDB's award of the aforementioned WIOA-funded subrecipient agreement to the ULA for the provision of Career Services in Medina and Summit Counties;

NOW THEREFORE, BE IT RESOLVED by the SAMWA COG, that:

SECTION 1

The Summit and Medina Workforce Area Council of Governments hereby awards the United Labor Agency with a subrecipient agreement, funded by Workforce Innovation and Opportunity Act (the "WIOA") Adult and Dislocated Worker funds, to provide Career Services in Medina and Summit Counties, in a not to exceed amount of \$1,468,155.00 for the period beginning on 10/1/2018 and ending on 9/30/2019, with the option to renew said contract for two additional 12-month terms.
