

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS

RESOLUTION 2019-14**

**A Resolution authorizing the first renewal of two, awarded by the Workforce Development Board of Workforce Innovation & Opportunity Act funds for four (4) Subrecipient Agreements with Summit County service providers, under the State of Ohio's Comprehensive Case Management Employment Program (CCMEP) model, to provide WIOA youth services for the period of 7/1/2019 to 6/30/2020, with one remaining 12-month renewal option.**

**WHEREAS**, the State of Ohio's publicly funded youth workforce programs are served through the Comprehensive Case Management Employment Program (the "CCMEP") as a single population under a consolidated system of service delivery, and requires the leveraging of federal Temporary Assistance for Needy Families (the "TANF") and Workforce Innovation & Opportunity Act (the "WIOA") funds; and

**WHEREAS**, the Ohio Department of Job & Family Services (the "ODJFS") allocates both TANF and WIOA funds to county level Job and Family Services departments and Ohio's designated Local Workforce Areas, respectively; and

**WHEREAS**, in Ohio Local Workforce Area 2 (the "Area 2"), comprised of Medina and Summit Counties, TANF funds are received by both the Medina and Summit Counties' Job and Family Services Departments and WIOA funds are received by the Summit & Medina Workforce Area Council of Governments (the "SAMWA COG"); and

**WHEREAS**, with Ohio's consolidation of the delivery of youth services through WIOA and TANF, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds, and that this responsibility cannot be transferred to another party, thereby resulting in the determination for a joint procurement process with the county level Departments of Job and Family Services; and

**WHEREAS**, on 3/26/18, a joint Request for Proposal packet was released by the Summit/Medina Workforce Development Board (the "WDB") and the County of Summit Department of Job and Family Services (the "CSDJFS") for the provision of CCMEP youth educational and employment services funded with both TANF and WIOA allocations; and

**WHEREAS**, at its meeting held 6/25/2018, the Summit County Council, adopted Resolution 2018-257, which awarded the TANF portion of various joint TANF- and WIOA-funded subrecipient agreements and at its 6/27/2018 meeting, the SAMWA COG, adopted Resolution 2018-13, which award the WIOA portion of various joint TANF- and WIOA funded subrecipient agreements, with the agreements for the period of 7/1/2018 to 6/30/2019, all with two 12-month renewal options, and

**WHEREAS**, at its 6/5/19 meeting, due to meeting performance measures, the WDB Executive Committee recommended to the SAMWA COG the renewal of the WIOA portion of various joint TANF- and WIOA-funded subrecipient agreements, for the period of 7/1/2019 to

6/30/2020, initiating the first of two 12-month renewal options, in a total amount not to exceed \$565,000.00; and

**WHEREAS**, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to initiate the first of two 12-month renewal options of the aforementioned TANF- and WIOA-funded subrecipient agreements for the provision of CCMEP youth services in Summit County;

**NOW THEREFORE, BE IT RESOLVED** by the SAMWA COG, that:

**SECTION 1**


Renewal of the award by the SAMWA COG of subrecipient agreements, between certain youth providers, the County of Summit Department of Job and Family Services, and the Summit and Medina Workforce Area Council of Governments, to provide in-school and out-of-school youth employment and educational services under Ohio's Comprehensive Case Management and Employment Program model in Summit County, for the period beginning 7/1/2019 and ending 6/30/2020, with one additional 12-month renewal option, in a total amount not to exceed \$2,225,000.00, as more fully set forth on Exhibit A, attached hereto and incorporated herein by reference, is hereby confirmed.


**SECTION 2**
