A Resolution adopting Workforce Area 2's Operating and Administrative Budgets for State Fiscal Year 2020 as recommended by the Summit and Medina Workforce Development Board at their regular meeting held on 6/27/2019.

WHEREAS, pursuant to the Workforce Innovation and Opportunity Act of 2014 ("WIOA"), the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG") was established to provide the governance structure through which the public workforce system in Ohio Local Workforce Area 2 ("Area 2"), comprised of Summit and Medina Counties and represented by the Summit/Medina Workforce Development Board (the "WDB"), operates; and

WHEREAS, upon its formation, the SAMWA COG assumed from Area 2's counties the responsibility to adopt operating and administrative budgets comprised of federal funds allocated for the provision of workforce development services to Adults, Dislocated Workers, Youth and businesses residing and/or located in Medina and Summit Counties, Ohio; and

WHEREAS, at its June 27, 2019 meeting, the WDB made its recommendation to the SAMWA COG to adopt Area 2's Operating Budget and Administrative budgets for the State Fiscal Year 2020 consisting of July 1, 2019 through June 30, 2020, due to the notice of receipt of SFY 2020 WIOA funds from the Ohio Department of Job and Family Services ("ODJFS"); and

WHEREAS, the SAMWA COG finds and determines, after reviewing the WDB Finance Committee's recommendation and all other pertinent information, that it is necessary and in the best interest of Area 2 to adopt the SFY 2020 Operating and Administrative Budgets for Area 2;

### NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

#### **SECTION 1**

The Operating and Administrative Budgets for the State Fiscal Year 2020 (period of July 1, 2019 through June 30, 2020), detailed in the table attached hereto as Exhibit A, is hereby adopted.

#### **SECTION 2**

This Directive shall take effect immediately upon its adoption.
