

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS  
FOR OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2020-14**

**A Resolution authorizing the second of two renewals of an award by the Summit/Medina Workforce Development Board of Workforce Innovation & Opportunity Act funds for a Subrecipient Agreement with United Labor Agency to provide Career Services in Medina and Summit Counties in an amount not to exceed \$1,774,926.00 during the period of 10/1/2020 to 9/30/2021.**

**WHEREAS**, the State of Ohio’s publically funded Adult and Dislocated Workforce Programs are served through Career Services provided under the Workforce Innovation & Opportunity Act (the “WIOA”);

**WHEREAS**, the Ohio Department of Job & Family Services (the “ODJFS”) allocates WIOA funds to Ohio’s designated Local Workforce Areas;

**WHEREAS**, in Ohio Local Workforce Area 2 (“Area 2”), comprised of Medina and Summit Counties, WIOA funds are received by the Summit and Medina Workforce Area Council of Governments (the “SAMWA COG”);

**WHEREAS**, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds;

**WHEREAS**, on 7/3/2018, a Request for Proposal packet was released by the Summit/Medina Workforce Development Board (the “Area 2 WDB”) for the provision of Career Services funded with WIOA allocations;

**WHEREAS**, at its 9/26/18 meeting, the SAMWA COG adopted Resolution 2018-22, confirming the award by the Summit/Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for a subrecipient agreement with the United Labor Agency to provide Career Services in Medina and Summit Counties, with two 12-month renewal options;

**WHEREAS**, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to initiate the second of two 12-month renewal options of the aforementioned WIOA-funded subrecipient agreement to the ULA for the provision of Career Services in Medina and Summit Counties;

**NOW THEREFORE, BE IT RESOLVED** by the SAMWA COG, that:

**SECTION 1**

Renewal of the award by the SAMWA COG of the subrecipient agreement with United Labor Agency, funded by Workforce Innovation and Opportunity Act (“WIOA”) Adult and Dislocated Worker funds, to provide Career Services in Medina and Summit Counties, in an amount not to exceed \$1,774,926.00, for the period beginning 10/1/2020 and ending 9/30/2021, is hereby confirmed.
