

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2021-22**

A Resolution authorizing the Summit/Medina Workforce Area Council of Governments (“SAMWA COG”) on the recommendation of the Summit/Medina Workforce Development Board (“WDB”) to award a Subrecipient agreement to United Labor Agency (“ULA”) to provide Adult and Dislocated Worker Career Services under the Workforce Innovation Opportunity Act in amounts not to exceed \$573,000.00 for Medina County and \$1,460,000.00 for Summit County for the period beginning 10/1/2021 and ending 9/30/2022.

WHEREAS, the State of Ohio’s publically funded Adult and Dislocated Worker Programs are served through Career Services provided under the Workforce Innovation & Opportunity Act (the “WIOA”);

WHEREAS, the Ohio Department of Job & Family Services (the “ODJFS”) allocates WIOA funds to Ohio’s designated Local Workforce Areas;

WHEREAS, in Ohio Local Workforce Area 2 (the “Area 2”), comprised of Medina and Summit Counties, WIOA funds are received by the Summit and Medina Workforce Area Council of Governments (the “SAMWA COG”);

WHEREAS, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds;

WHEREAS, the Area 2 WDB recommended at its 9/30/2021 meeting that the SAMWA COG award the ULA with a Subrecipient agreement to provide Career Services in Medina and Summit Counties;

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to confirm the WDB’s award of the aforementioned WIOA-funded Subrecipient agreement to the ULA for the provision of Career Services in Medina and Summit Counties;

NOW THEREFORE, BE IT RESOLVED by the SAMWA COG, that:

SECTION 1

The Summit and Medina Workforce Area Council of Governments hereby awards the United Labor Agency with a Subrecipient agreement, funded by Workforce Innovation and Opportunity Act (the “WIOA”) Adult and Dislocated Worker funds, to provide Career Services in Medina and Summit Counties, in amounts not to exceed \$573,000.00 for Medina County and \$1,460,000.00 for Summit County, for the period beginning 10/1/2021 and ending 9/30/2022.

SECTION 2

WIOA funding awarded to the United Labor Agency’s Subrecipient agreement to provide Summit and Medina County Career Services is as follows:




