

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2021-23**

A Resolution authorizing the Summit and Medina Workforce Area Council of Governments to reallocate a portion of the balance of Year 2 (Program Year 2020) Summit Workforce Innovation and Opportunity Act (“WIOA”) Adult Program, Youth Program, and SAMWA COG Administration Funds, liquidating 9/30/2021, to reimburse Year 2 Medina WIOA Program expenditures charged against Year 1 (Program Year 2021) Medina WIOA Program Funds.

WHEREAS, Ohio Local Workforce Area 2 (the "Area 2"), created under the Workforce Innovation and Opportunity Act of 2014 (the “WIOA”), administers the public workforce development system in Summit and Medina Counties as governed by the Summit and Medina Workforce Area Council of Governments (the “SAMWA COG”), through its intergovernmental agreement dated November 1, 2016, between the chief elected officials of the Counties, which addresses the logistics of Area 2's functions and fiscal responsibilities;

WHEREAS, Area 2’s Fiscal Agent, the County of Summit Department of Finance and Budget (the “CSDFB”), has determined a need to reallocate a portion of Year 2 Summit WIOA Adult and Youth Program Funds and SAMWA COG Administration funds, totaling \$211,190.95 to Year 2 Medina WIOA Program Funds during the process of liquidating Program Year 2020;

WHEREAS, the SAMWA COG Board finds and determines that it is necessary and in the best interest of Area 2 to appropriate the aforementioned funds;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG, that:

SECTION 1

The reallocation of a portion of the available balance of Workforce Area 2’s Year 2 Summit Workforce Innovation and Opportunity Act Adult Program, Youth Program, and SAMWA COG Administration funds, totaling \$211,190.95 shall be reallocated to Year 2 Medina WIOA Program Funds as follows:

SECTION 2

The Area 2 Fiscal Agent, the County of Summit Department of Finance and Budget, is hereby authorized and directed to make the Workforce Area’s reallocations.

SECTION 3

This Directive shall take effect immediately upon its adoption.
