THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR OHIO LOCAL WORKFORCE AREA 2 RESOLUTION 2023-06

A Resolution authorizing the second renewal of two awarded by the Summit and Medina Workforce Development Board of Workforce Innovation Opportunity Act (WIOA) funds for three (3) Subrecipient Agreements with Summit County service providers, under the State of Ohio's Comprehensive Case Management Employment Program (CCMEP) model, to provide WIOA youth services for the period of 7/1/2023 to 6/30/2024, with no remaining renewal options.

WHEREAS, the State of Ohio's publicly funded youth workforce programs are served through the Comprehensive Case Management Employment Program ("CCMEP") as a single population under a consolidated system of service delivery, and requires the leveraging of federal Temporary Assistance for Needy Families ("TANF") and Workforce Innovation & Opportunity Act ("WIOA") funds;

WHEREAS, the Ohio Department of Job & Family Services ("ODJFS") allocates both TANF and WIOA funds to county level Job and Family Services departments and Ohio's designated Local Workforce Areas, respectively;

WHEREAS, in Ohio Local Workforce Area 2 ("Area 2"), comprised of Medina and Summit Counties, TANF funds are received by both the Medina and Summit Counties' Job and Family Services Departments and WIOA funds are received by the Summit & Medina Workforce Area Council of Governments ("SAMWA COG");

WHEREAS, with Ohio's consolidation of the delivery of youth services through WIOA and TANF, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds, and that this responsibility cannot be transferred to another party, thereby resulting in the determination for a joint procurement process with the county level Departments of Job and Family Services;

WHEREAS, on 2/22/2021, a joint Request for Proposal packet was released by the Summit/Medina Workforce Development Board ("WDB") and the County of Summit Department of Job and Family Services ("CSDJFS") for the provision of CCMEP youth educational and employment services funded with both TANF and WIOA allocations;

WHEREAS, at its meeting held 6/28/2021, the Summit County Council, on behalf of CSDJFS, adopted Resolution 2018-257, which awarded the TANF portion of various joint TANF-and WIOA-funded subrecipient agreements, held between three (3) providers, for the period of 7/1/2021 to 6/30/2022, with two 12-month renewal options, in a total amount not to exceed \$1,466,839.57 in TANF funding;

WHEREAS, at its 6/24/2021 meeting, the WDB recommended to the SAMWA COG the award of the WIOA portion of various subrecipient agreements, held between three (3) providers, for the period of 7/1/2021 to 6/30/2022, with two 12-month renewal options, in a total amount not to exceed \$571,165.92 in WIOA funding;

WHEREAS, all parties recognize and affirm the aforementioned agreements to various Summit County service providers, which shall be issued jointly with TANF and WIOA funds, total \$2,038,005.49, and;

WHEREAS, at its 6/24/2021 meeting, the SAMWA COG resolved to confirm the award by the Summit/Medina Workforce Development Board of Workforce Innovation & Opportunity Act funds for subrecipient agreements with various Summit County service providers, under the structure of the Comprehensive Case Management Employment Program (CCMEP), to provide youth services in Summit County, for the period of 7/1/2021 to 6/30/2022, with two 12-month renewal options, and;

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to initiate the second of two 12-month renewal options of the aforementioned TANF- and WIOA-funded subrecipient agreements for the provision of CCMEP youth services in Summit County with increases to two of the three providers as referenced in Exhibit A;

NOW THEREFORE, BE IT RESOLVED by the SAMWA COG, that:

SECTION 1

Renewal of the award by the SAMWA COG of subrecipient agreements, between certain providers, the County of Summit Department of Job and Family Services, and the Summit and Medina Workforce Area Council of Governments, to provide in-school and out-of-school youth employment and educational services under the Comprehensive Case Management and Employment Program in Summit County, for the period beginning 7/1/2023 and ending 6/30/2024, with no additional renewal options, in a total amount not to exceed \$2,250,639.49, as more fully set forth on Exhibit A, attached hereto and incorporated herein by reference, is hereby confirmed.

SECTION 2

This directive shall take effect on July 1, 2023.
