

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR
OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2023-08**

A Resolution confirming the award by the Summit/Medina Workforce Development Board of a contractor agreement renewal (third of three) with the County of Summit Department of Job & Family Services to operate Ohio Local Workforce Area 2's comprehensive One-Stop Center, the OhioMeansJobs Summit County Center, in an amount not to exceed \$226,767.93, for the period of 7/1/2023 to 6/30/2024.

WHEREAS, the Summit and Medina Workforce Area Council of Governments ("SAMWA COG"), at its meeting held 6/25/2020, adopted Resolution 2020-09, which confirmed the Summit/Medina Workforce Development Board's ("WDB") award of a contractor agreement to the County of Summit Department of Job & Family Services ("SCDJFS") to operate Ohio Local Workforce Area 2's ("Area 2") comprehensive One-Stop Center ("OSC"), the OhioMeansJobs Summit County ("OMJSC") Center, in an amount not to exceed \$228,109.71 of OSC Memorandum of Understanding ("MOU") Partner funds, for the period of 7/1/2020 through 6/30/2021, with the option to renew said contract for three additional 12-month terms;

WHEREAS, at its meeting held 6/24/2021, the SAMWA COG adopted resolution 2021-10 awarding a contractor agreement renewal (first of three) to the SCDJFS, to operate the OMJSC Center during the period of 7/1/2021 to 6/30/2022, in an amount not to exceed \$227,430.77 of OSC MOU Partner funds, and;

WHEREAS, at its meeting held 7/6/2022, the SAMWA COG adopted resolution 2022-10 awarding a contractor agreement renewal (second of three) to the SCDJFS, to operate the OMJSC Center during the period of 7/1/2022 to 6/30/2023, in an amount not to exceed \$230,000.00 of OSC MOU Partner funds, and;

WHEREAS the SAMWA COG finds and determines that it is necessary and in the best interest of Area 2 to confirm the award of the available third renewal to the SCDJFS during the period of 7/1/2023 to 6/30/2024, in an amount not to exceed \$226,767.93 of OSC MOU Partner funds;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

SECTION 1

The Summit and Medina Workforce Area Council of Governments hereby confirms the Summit/Medina Workforce Development Board's award of a contractor agreement renewal (third of three) to the County of Summit Department of Job & Family Services to operate Area 2's comprehensive One-Stop Center, the OhioMeansJobs Summit County Center, in an amount not to exceed \$226,767.93 of OSC MOU funds, for the period of 7/1/2023 to 6/30/2024.


SECTION 2

This directive shall take effect on July 1, 2023.
