

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2024-03**

A Resolution of the Summit and Medina Workforce Area Council of Governments confirming the award of the Workforce Innovation and Opportunity Act (WIOA) funds in the joint contract with Summit County Department of Job and Family Services approved by Summit County Council Resolution No. 2022-267 for a contractor agreement with Nesco Resource, LLC fka Callos Resource LLC, for payroll services for the initial period of 10/01/22 through 09/30/23 and the renewal period of 10/01/23 through 09/30/24 as approved by Summit County Council Resolution No. 2023-236, for youth and young adults enrolled in the Comprehensive Case Management Employment Program (CCMEP) and participating in work experience, with two options remaining to renew for one-year agreements in an amount not to exceed \$200,000.00.

WHEREAS, the State of Ohio's publicly funded youth workforce programs are served through the Comprehensive Case Management Employment Program (the "CCMEP") as a single population under a consolidated system of service delivery, and requires the leveraging of federal Temporary Assistance for Needy Families (the "TANF") and Workforce Innovation & Opportunity Act (the "WIOA") funds;

WHEREAS, the Ohio Department of Job & Family Services (the "ODJFS") allocates TANF and WIOA funds to county level Job and Family Services departments and Ohio's 20 designated Local Workforce Areas, respectively;

WHEREAS, in Ohio Local Workforce Area 2 (the "Area 2"), comprised of Medina and Summit Counties, TANF funds are received by both the Medina and Summit Counties' Job and Family Services departments and WIOA funds are received by the Summit & Medina Workforce Area Council of Governments (the "SAMWA COG");

WHEREAS, with Ohio's consolidation of the delivery of youth services through WIOA and TANF, the United States Department of Labor maintains the requirement that local Workforce Development Boards are responsible for the procurement and monitoring of all contractor agreements purchased and rendered utilizing WIOA funds, and that this responsibility cannot be transferred to another party, thereby resulting in the determination for a joint procurement process with the county level Job and Family Services departments;

WHEREAS, the Summit County Council, on behalf of the County of Summit Department of Job & Family Services, put forth Resolution 2022-267, to the joint TANF- and WIOA-funded contractor agreement for CCMEP Payroll Services to Nesco Resource, LLC fka Callos Resource LLC, for the initial period of 10/01/22 to 9/30/2023;

WHEREAS, the Summit County Council, on behalf of the County of Summit Department of Job & Family Services, put forth Resolution 2023-236, to the joint TANF- and WIOA-funded contractor agreement for CCMEP Payroll Services to Nesco Resource, LLC fka Callos Resource LLC, for the renewal period of 10/01/23 to 9/30/2024;

WHEREAS, the SAMWA COG finds and determines that it is necessary and in the best interests of Area 2 to confirm the award and renewals of WIOA funds for the aforementioned

TANF- and WIOA-funded contractor agreement to Nesco Resource, LLC fka Callos Resource LLC, for the provision of CCMEP Work Experience payroll services in Summit County;

NOW THEREFORE, BE IT RESOLVED by the SAMWA COG, that:

SECTION 1

The award by the SAMWA COG of Workforce Innovation and Opportunity Act funds (the "WIOA") for a contractor agreement, jointly funded by WIOA and Temporary Assistance for Needy Families (the "TANF"), to Nesco Resource, LLC fka Callos Resource LLC, held between Nesco Resource, LLC fka Callos Resource LLC, the County of Summit Department of Job and Family Services, and the SAMWA COG, to provide payroll services to Comprehensive Case Management Employment Program (the "CCMEP") youth enrolled in CCMEP Work Experiences under the Act, awarding the initial and first renewal for the period of 10/01/2022 to 9/30/2024, and allowing for the remaining two 12-month renewal options, is hereby confirmed.

SECTION 2

This directive shall be retroactively effective as of October 01, 2022.
