## THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR OHIO LOCAL WORKFORCE AREA 2 RESOLUTION 2024-08

A Resolution authorizing the Summit and Medina Workforce Area Council of Governments, on the recommendation of the Summit Medina Workforce Development Board, to award a Subrecipient Agreement to KRA Corporation to provide Adult and Dislocated Worker Career Services under the Workforce Innovation and Opportunity Act in an amount not to exceed \$1,900,000.00 for the period beginning 7/1/2024 and ending 6/30/2025.

WHEREAS, the State of Ohio's publicly funded Adult and Dislocated Worker Programs are served through Career Services provided under the Workforce Innovation and Opportunity Act of 2014 ("WIOA");

WHEREAS, the Ohio Department of Job and Family Services ("ODJFS") allocates WIOA funds to Ohio's designated Local Workforce Areas;

WHEREAS, in Ohio Local Workforce Area 2 ("Area 2"), comprised of Medina and Summit Counties, WIOA funds are received by the Summit and Medina Workforce Area Council of Governments ("SAMWA COG");

WHEREAS, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds;

WHEREAS, on 1/31/2024, a Request for Proposals was released by the Summit Medina Workforce Development Board ("WDB") for the provision of Adult and Dislocated Worker Career Services funded with WIOA allocations;

**WHEREAS**, at its 6/21/2024 meeting, the WDB recommended to the SAMWA COG the award of a WIOA-funded Subrecipient Agreement to KRA Corporation ("KRA"), for the period of 7/1/2024 to 6/30/2025, with three (3) 12-month renewal options, in a total amount not to exceed \$1,900,000.00; and

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to confirm the WDB's award of the aforementioned WIOA-funded Subrecipient Agreement to KRA for the provision of Adult and Dislocated Worker Career Services in Medina and Summit Counties.

#### **NOW THEREFORE, BE IT RESOLVED** by the SAMWA COG, that:

### **SECTION 1**

The Summit and Medina Workforce Area Council of Governments hereby awards KRA Corporation with a Subrecipient Agreement funded by Workforce Innovation and Opportunity Act Adult and Dislocated Worker allocations, to provide Career Services in Medina and Summit Counties, in an amount not to exceed \$1,900,000.00, for the period beginning 7/1/2024 and ending 6/30/2025.
