

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS

RESOLUTION 2026-05**

**A Resolution authorizing the first renewal of three awarded by the Summit and Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for a Subrecipient Agreement with Tri-County Jobs for Ohio's Graduates, under the structure of the State of Ohio's Comprehensive Case Management Employment Program, to provide youth services in Summit County in an amount not to exceed \$600,000.00 for the period of July 1, 2026 through June 30, 2027, with two remaining 12-month renewal options.**

**WHEREAS**, the State of Ohio's publicly funded youth workforce programs are served through the Comprehensive Case Management Employment Program ("CCMEP") as a single population under a consolidated system of service delivery, and requires the leveraging of federal Temporary Assistance for Needy Families ("TANF") and Workforce Innovation and Opportunity Act of 2014 ("WIOA") funds;

**WHEREAS**, the Ohio Department of Job and Family Services ("ODJFS") allocates both TANF and WIOA funds to county level Job and Family Services departments and Ohio's designated Local Workforce Areas, respectively;

**WHEREAS**, in Ohio Local Workforce Area 2 ("Area 2"), comprised of Medina and Summit Counties, TANF funds are received by both the Medina and Summit Counties' Job and Family Services Departments and WIOA funds are received by the Summit and Medina Workforce Area Council of Governments ("SAMWA COG");

**WHEREAS**, with Ohio's consolidation of the delivery of youth services through WIOA and TANF, the United States Department of Labor maintains the requirement that a local Workforce Development Board is responsible for the procurement and monitoring of all services purchased and rendered utilizing WIOA funds, and that this responsibility cannot be transferred to another party, thereby resulting in the determination for a joint procurement process with the county level Departments of Job and Family Services;

**WHEREAS**, on 02/03/2025, a joint Request for Proposal packet was released by the Summit Medina Workforce Development Board ("WDB") and the County of Summit Department of Job and Family Services ("CSDJFS") for the provision of CCMEP youth educational and employment services in Summit County, funded with both TANF and WIOA allocations;

**WHEREAS**, at its 06/16/2025 meeting, the Summit County Council, on behalf of CSDJFS, adopted a resolution awarding the TANF portion of the joint TANF- and WIOA-funded CCMEP subrecipient agreement to Tri-County Jobs for Ohio's Graduates ("JOG"), for the period of 07/01/2025 to 06/30/2026, with three (3) 12-month renewal options, in a total amount not to exceed \$1,400,000.00 in TANF funding;

**WHEREAS**, at its 06/12/2025 meeting, the WDB recommended to the SAMWA COG the award of the WIOA portion of a joint TANF and WIOA-funded CCMEP subrecipient agreement to JOG, for the period of 07/01/2025 to 06/30/2026, with three (3) 12-month renewal options, in a total amount not to exceed \$600,000.00 in WIOA funding;

**WHEREAS**, at its 06/12/2025 meeting, the SAMWA COG resolved to confirm the award by the Summit Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for subrecipient agreement with JOG, under the structure of the CCMEP, to provide

youth services in Summit County, for the period of 07/01/2025 to 06/30/2026, with three (3) 12-month renewal options; and

**WHEREAS**, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to initiate the first of three (3) 12-month renewal options of the aforementioned TANF and WIOA-funded subrecipient agreements for the provision of CCMEP youth services in Summit County.

**NOW THEREFORE, BE IT RESOLVED** by the SAMWA COG, that:

**SECTION 1**

Renewal of the award by the SAMWA COG of subrecipient agreement, between Tri-County Jobs for Ohio's Graduates, County of Summit Department of Job and Family Services, and the Summit and Medina Workforce Area Council of Governments, to provide in-school and out-of-school youth employment and educational services under the Comprehensive Case Management and Employment Program in Summit County, for the period beginning July 1, 2026 through June 30, 2027, with two (2) remaining 12-month renewal options, in a total amount not to exceed \$2,000,000.00, as more fully set forth on *Exhibit A*, attached hereto and incorporated herein by reference, is hereby confirmed.

**SECTION 2**

This directive shall take effect on July 1, 2026.
