

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2026-07**

A Resolution authorizing the second renewal of three awarded by the Summit Medina Workforce Development Board to KRA Corporation to provide One-Stop Operator Services, as defined by the Workforce Innovation and Opportunity Act, at the OhioMeansJobs Medina County and OhioMeansJobs Summit County American Job Centers for the period beginning July 1, 2026 and ending June 30, 2027, in an amount not to exceed \$190,000.00 of combined One-Stop Center Memorandum of Understanding Partner funds.

WHEREAS, the United States Department of Labor's Employment and Training Administration funds a network of American Job Centers ("AJC") centers, also known as One-Stop centers, to provide free employment assistance to job seekers at AJC network locations across the country;

WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act of 2014 ("WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure the Operators of AJCs;

WHEREAS, on 01/31/2024, a Request for Proposals was released by the Summit Medina Workforce Development Board ("WDB") to competitively procure the Operator for the Ohio Local Workforce Area 2 ("Area 2") AJCs, branded in the State of Ohio as OhioMeansJobs Medina County ("OMJMC") and OhioMeansJobs Summit County ("OMJSC");

WHEREAS, at its 06/21/2024 meeting, the WDB recommended to the Summit and Medina Workforce Area Council of Governments ("SAMWA COG") the award of a contract to KRA Corporation ("KRA") for One-Stop Operator Services in Medina and Summit Counties for the period of 07/01/2024 to 06/30/2025, with three (3) 12-month renewal options, in a total amount not to exceed \$175,000.00 in One-Stop Partner Memorandum of Understanding ("MOU") funds;

WHEREAS, at its 06/25/2026 meeting, the WDB authorized the second of three (3) renewals of the One-Stop Operator Services contract to KRA for the period of 07/1/2026 to 06/30/2027 with one (1) 12-month renewal option remaining, in a total amount not to exceed \$190,000.00; and

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and having received the recommendation of the WDB, that it is necessary and in the best interest of Area 2 to confirm the WDB's award of the aforementioned One-Stop Operator Services contract to KRA for the purpose of operating the OMJMC and the OMJSC.

NOW THEREFORE, BE IT RESOLVED by the SAMWA COG, that:

SECTION 1

The Summit and Medina Workforce Area Council of Governments hereby awards KRA Corporation a contract to provide One-Stop Operator Services at OhioMeansJobs Medina County and OhioMeansJobs Summit County in an amount not to exceed \$190,000.00 for the period beginning July 1, 2026 through June 30, 2027.
